EDGE GROVE BURSARY -THE GIFT OF EDUCATION

Edge Grove is a vibrant and successful independent day and boarding school for boys and girls between the ages of 3 and 13, characterised by a genuine commitment to the pursuit of excellence. Its vision is to ensure that every pupil can achieve their full potential within a safe, secure and happy learning environment.

The School is proud of its long standing tradition of nurturing talent and is committed to ensuring that it is accessible to pupils irrespective of parental income. The School ensures that funds are made available to subsidise places at Edge Grove for deserving and talented children whose parents would not otherwise be able to afford to send their children to the School. Bursary funding also facilitates the continued education of children from families experiencing unforeseen or temporary financial hardship.

Typically, in one academic year, 16 pupils have benefited from means tested financial assistance, some of whom received a bursary of 90% or more.



FREQUENTLY ASKED QUESTIONS:

Who can benefit from bursary support?

Bursary funding, subject to an annual review, is available to support pupils each year whose family circumstances mean that they need help with all or a portion of the cost of fees. Support may be given to children from years 3 to 8.

How much help is given?

Generally between 50% and 95% of the fees are awarded; we may ask for a 5% contribution from the bursary parents. Where a very high level bursary is awarded, parents may also apply for additional funding to cover the costs of uniform and 'extras'.

How are children selected?

Applications for means tested bursaries are assessed by the Governor's finance committee, after the family's financial circumstances have been considered. Children are assessed in the same way as any prospective pupil.

How can you help?

You can support the Edge Grove Bursary Fund with one-off gifts, regular giving or a pledge to be fulfilled at an agreed date in the future. Regular monthly donations are welcome via a standing order to the school. Gift Aid maximises the value of gifts to Edge Grove and higher rate tax payers can also claim additional tax relief via their tax return.

Example of how Gift Aid can benefit the donor and the School:
