If our child requires a Certificate of Sponsorship (CAS) to support an application for a UK Visa, this will be charged by the School at a further £100 in advance of the application and this payment must be made along with the registration fee prior to the certificate being requested. Granting of a CAS does not grant an automatic place at the School.
6. We must immediately inform the School if any of the details provided in this Registration Form change;
7. In the event that our child is offered a place at Edge Grove, such an offer will be subject to Edge Grove Terms and Conditions for the provision of educational services, which will bind us in the event that we accept the place.
